## New conditions apply to ANBIs as of January 1st 2014

As of January 1st 2014 new conditions apply to ANBIs when they will have to publish a number of particulars on an internet site.

### Publishing particulars on an ANBI internet site

As of January 1st 2014 an ANBI must publish the following particulars on an internet site:

- The institution's name
- The RSIN (Legal Entities & Partnerships Identification Number)/Tax number
- The contact details
- The ANBI's object
- The policy plan
- The position of the directors
- The names of the directors
- The payment policy - refer to the GBA or salary scheme for personnel where applicable
- A report of the activities that have already been carried out
- A [financial statement](#)

An ANBI can publish the required particulars on its own internet site or on the collective internet site of for example a branch organization.

#### **! Please note!**

A number of [exceptions](#) apply when publishing particulars on the internet.
